

**THE SALWEEN DISTRICT (EXTENSION OF LAWS) ACT, 1949.\***

[ACT NO. LXI OF 1949.] The 20th October 1949.

WHEREAS it is expedient to extend the provisions of certain enactments to the Salween District; it is hereby enacted as follows:-

1. This Act may be called **the Salween District (Extension of Laws) Act, 1949**.
2. The enactments mentioned in column (1) of the Schedule shall apply to the Salween District, subject to the modifications and adaptations, if any, set forth in column (2).
3. Subject to the provisions of the Constitution, the President may, by notification, make such further modifications and adaptations in column (2) of the Schedule in respect of any enactment mentioned therein or in respect of any rules or regulations made under the said enactments, as may be required by the exigencies of the Salween District.
4. Subject to the provisions of sections 2 and 3, the provisions contained in any enactment mentioned in the Schedule shall be void in so far as they are inconsistent with the provisions of any Act of the Parliament.
